

To obtain locally used forms when the library is closed, go to the Grayson County website (Google “Grayson County”) and under Directory or Public drop down menu select “Law Library.” The page URL is: <http://www.co.grayson.tx.us/default.aspx?name=dall.home>

In the left hand size navigation menu, “Online Catalog” is the third link. Click on that to access the catalog.

Then type in key words into the search box and click on the search icon, which looks like a magnifying glass. If you type in “DBA”, (without the quotes), you will get two forms for assumed name/doing business as. Click on the record title (hyperlinked in blue) and then click on the icon image preview of the form, or the form title, and it will open up a PDF version of the form that you can then print or download.
