JURY DUTY

All Individuals are considered competent to serve on a jury and are obligated to serve unless disqualified by law or excused by the court. General Qualifications for jury service are listed below. A Court may consider any reasonable sworn excuse as grounds for release from or postponement of jury service.

RIGHT TO REEMPLOYMENT

A private employer may not terminate the employment of a permanent employee because the employee serves as a juror. An employee whose employment is terminated is a violation of Civil Practice and Remedies Code, Section 122.001.
